

GLENPOOL IN-TOWN GUEST WAIVER 2020

Assumption of the Risk and Waiver of Liability Relating to COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, Federal, State and Local Governments and Federal and State Health Agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Glenpool Club Inc., (“the Club”) has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or your child/children will not become infected with COVID-19. Further, attending the Club could increase your risk and your child/children’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child/children and I may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child/children or myself (including, but not limited to, personal injury, illness, permanent disability, and/or death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child/children may experience or incur in connection with my child/children’s attendance at the Club or participation in Club programming (“Claims”). On my behalf, and on behalf of my child/children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, officers, board of directors, and representatives, of and from the Claims, including all liabilities, claims actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, officers, board of directors, and representatives, whether a COVID-19 infection occurs before, during or after participation at any Club program.
